## LAND APPROPRIATION WITHOUT COMPENSATION BILL

#### A GOOD DAY FOR SOUTH AFRICA

Commenting on the failure of the ANC to garner a two thirds majority in Parliament for the Land Appropriation without Compensation Bill on Tuesday; the Party leader of the Christian Democratic Party (CDP) said: "This Bill, should it have been accepted, would have opened the door to full control over all public and privately owned property in South Africa, by the State. This would have been yet another nail in the coffin for the economy and food security in the country."

Responding to a statement made by the ANC's Matola Moshega, that the defeat of the Bill did not mean the end of the road for expropriation of land and that there were other avenues open to the ANC to ensure the process continues. Botha said: "This is exactly what had consistently been argued by those opposing the amendment of the Constitution in order to facilitate the process."

"This vote certainly averted another crisis for the country and was indeed a victory for all the hardworking citizens of South Africa that aspired to owning their own piece of land and to paint their own front door. This concept is also fully in line with Biblical Principles" Botha said.

## GRONDONTIENING SONDER VERGOEDING WETSONTWERP

### PERSVERKLARING

#### 'N GOEIE DAG VIR SUID AFRIKA

In kommentaar oor die ANC se gebreke om Dinsdag 'n twee derde meerderheidstem ten gunste van Onteïening sonder Vergoeding in die Parlement te behaal; het die Partyleier van die Christen Demokratiese Party (CDP) gesê: "Hierdie Wetgewing, sou dit aanvaar word, sou die deur na volle staatsbeheer oor alle eiendom in publieke en privaat besit in Suid Afrika oopmaak. Dit sou nog 'n spyker in die doodskis van die land se ekonomie en voedselsekuriteit wees."
